Specifically, renewable energy production complemented by battery storage and electric vehicles have seen significant traction in multiple geographies like the US, Korea, China as well as in India (Globally, Energy Storage deployment grew 16x and Electric Vehicles sales (BEV &PHEV) grew 7x from 2013-18).
